ANSWER: E

Explanation:

"Huckabees, Jason Schwartzman's performance being one reason" has "being" and is redundant to boot. "Huckabees, Jason Schwartzman's performance is only one of them" and "Huckabees, the performance of Jason Schwartzman is one of them" are run-ons. "Huckabees; Jason Schwartzman's performance, for one" is semicolon misuse: the semicolon is not followed by an independent clause.

The problem with this sentence is the misplacement of the clause that describes jewelry. By placing "...including watches, necklaces, and earrings." after "classes" the reader gets the impression that the classes involves different types of jewelry. By moving the clause, choice "Jewelry, including watches, necklaces and earrings, is an accessory used by members of all classes" and choice "Jewelry, including watches, necklaces and earrings, are an accessory used by members of all classes" improve the sentence. However, choice "Jewelry, including watches, necklaces and earrings, are an accessory used by members of all classes" commits the error of using a plural form of "to be" (i.e. are) to refer to a collective noun like jewelry that demands a singular verb (i.e. is). Only choice "Jewelry, including watches, necklaces and earrings, is an accessory used by members of all classes" places the clause correctly after "jewelry" and ensures that the verb agrees with the subject.

QUESTION NO: 3

ANSWER: A

Explanation:

The correct answer is "who" because "who" is the object of this sentence. Remember that "who" is the correct pronoun choice for the subject of a sentence, while "whom" is always an object. While the object generally comes closer to the end of most sentences, questions are often structured with the object near the beginning. To correct this sentence, just substitute "whom" for "who." Another hint that this sentence requires "whom" rather than "who" is that the word falls after the preposition "to." Therefore, even if you didn't recognize "who" as the object of the sentence, you could still see that it's the object of a preposition and needs to be changed to "whom."

ANSWER: C

Explanation:

The correct answer is "tree's" because there are many trees that shed all those leaves each fall. To show that a singular noun owns something, the apostrophe goes in front of the "s." To show that a plural noun own something, the apostrophe goes in after of the "s." Changing "tree's" to "trees" would correct the error in this sentence by reflecting that the leaves in Neal's yard come from many trees, not just one.

Explanation:

The problem with this sentence is that the second action verb (i.e. enhance) needs to be singular (i.e. enhances) because this verb refers to "insight." Some readers may believe that because there are two characteristics to the insight (i.e. informative and witty) there should be a plural form of the verb. Choice "enhances the sports-watching experience" and choice "enhances the sports-watching experience for fans" correct this agreement error of the verb; however, choice "enhances the sports-watching experience for fans" is wordy. Obviously, fans are the ones who watch sports, so why restate this. Choice "enhances the sports-watching experience" therefore is most direct and grammatically sound.

Explanation:
