Agent-based Provisioning

- An agent (windows service, linux daemon) installed to the local environment brokers Provisioning transaction requests between Okta and the on-premise resource.
- Currently Supported Provisioning agents Active Directory
- LDAP
- On Premise Provisioning
- This agent is generic and intended to connect to any On-Prem resource that can use the SCIM (Secure Cross-domain Identity Management) language.
- This typically involves code and a Professional Services Statement Of Work
- For more information, consult our On Premises Provisioning Deployment Guide
- This is a good, robust strategy. However, it is limited to on-premise applications.
